# State Points

Most shuffleboard organizations keep track of the number of points their members have earned from their tournaments. The purpose of these points varies, but is typically used to determine if a player has amateur, expert, and/or hall of fame status.

The purpose of state points in the Illinois Shuffleboard Association (ILSA) is to encourage participation in shuffleboard events in Illinois, encourage ILSA members to represent our association more broadly, and fuel competition among our membership. At this point, ILSA will not use points to determine player status, but accumulated points may be used for this in the future.

## Point Structure Overview

Members can earn points by playing in a variety of competitions. The earning potential is calculated separately for each competition and is structured in a way that considers characteristics such as total number of competitors, type of entry, format and level of play, and accessibility. Each factor and the calculation thereof is described in detail below.

#### **Factors**

The earning potential for each competition is comprised of three factors:

- 1. Base points determined by a combination of two components:
  - a. Number of competitors
  - b. Placement or participation
- 2. Entry type singles, doubles, or other team format
- 3. Competition host and type
  - ILSA, Community Member recognized by ILSA (e.g. Royal Palms), or other
  - b. Singles leagues, national or other tournaments

### Calculation

Total points awarded are calculated as follows:

- 1. Base points
- 2. Multiplied by the entry type
- 3. Multiplied by the competition host/type
- 4. Rounded to the nearest whole number





## Base Points (Factor 1)

Base points are determined by a combination of a competitor's final rank in a competition and the total number of participants.

A competitor is defined as an entry into the competition, which can be a player or a team. For example, a 16 team doubles tournament has 16 competitors despite having 32 total players.

#### Placement Points:

- Placement points will be awarded when the competitor has won one or more matches.
- In competitions where a qualifying round is used before a bracket (e.g. group play before bracket), **placement** points will be awarded to competitors who reach the bracket; competitors who do not reach the bracket will be awarded **participation** points.
- Placement points are multiplied by the factors described below.

#### Placement Points Scale

The number of base points by placement and number of competitors are defined as follows:

Placement Points - Consolation Bracket

### Participation Points:

- A participation point (1) is awarded to all competitors that do not receive points from placement, provided they complete all scheduled matches without forfeiting.
- Participation points are also multiplied by the factors described below.

#### **Exceptions:**

- If a tie is not broken, the lesser number of points will be awarded.
  - For example, if a 3<sup>rd</sup>/4<sup>th</sup> place match is not played, points would be awarded to both competitors for 4<sup>th</sup> placement.
- If a competition has divisions separated by gender, all divisions will be calculated as though they had the same number of participants from the largest division.
- Not all competitions have consolation rounds; consolation placement points will not be awarded where no such placements exist.

Note: There are currently no exceptions if a competitor forfeits a match. For ILSA run tournaments or leagues, contact the tournament director/assigned commission to learn best ways to avoid a forfeit. ILSA executive board will not intervene on forfeits during community member events or those held outside of Illinois.

<u>EXAMPLE STEP 1</u> - in a tournament or league with 40 competitors, the base points are found in the column labeled <u>33-64</u>. Placement for 4<sup>th</sup> Main would have 5 base points.

## Entry Type (Factor 2)

The number of individuals registering for a competition under a single unit defines the Entry Type. Variations include:

- Singles: two individuals competing against one another
- Doubles: two teams comprised of two individuals competing against each other, with one member from team A and B on each end of the court and where partners remain the same throughout the competition
- Other Team: any other competition with teams comprised of two or more individuals

Each ILSA member on a team (doubles or otherwise) will be awarded the full number of points earned (i.e. points are not divided among teammates).

### **Entry Type Multipliers**

The multiplier for each Entry Type is as follows:

Entry Type	Multiplier
Singles	1.5 x
Doubles	1.0 x
Other Team	0.5 x

<u>EXAMPLE STEP 2</u> - in a singles tournament or league with 40 competitors, 4th place main has 7.5 points at this stage of the calculation:

- 5 base points
- Multiplied by 1.50 for the entry type being singles = 7.5

## Competition Host and Type (Factor 3)

### **Competition Host**

The entity taking ownership of the organization and/or operations of the competition is known as the Competition Host. Possible competition hosts include:

- Illinois Shuffleboard Association (ILSA)
- Community Members recognized by ILSA. Such hosts reserve the right to opt-out of allowing ILSA to award points for their competitions by notifying ILSA's Executive Board.
- Other hosts including but not limited to state, national, or international associations and clubs

## Competition Host and Type Multipliers

The multiplier for each combination of Competition Host x Type are as follows:

- † In 2024 this was known as the Challenge Division
- ‡ In 2024 this was known as the FUNdamentals Division

<u>EXAMPLE STEP 3</u> - in an ILSA Top Tier Singles League with 40 competitors, 4<sup>th</sup> place main has 11.25 points at this stage of the calculation:

- 5 base points
- Multiplied by 1.50 for the entry type being singles = 7.5
- Multiplied by 1.50 for the competition host/type being ILSA Top Tier Singles = 11.25

# Rounding

with full example

Points are rounded to the nearest whole number for the purpose of simple and easy record keeping.

<u>EXAMPLE STEPS 1-4</u> - in an ILSA Top Tier Singles League with 40 competitors, 4<sup>th</sup> place main receives 11 total points:

- 5 base points
- Multiplied by 1.50 for the entry type being singles = 7.5
- Multiplied by 1.50 for the competition host/type being ILSA Top Tier Singles = 11.25
- Rounded down to 11 points
- The participation point is multiplied by both factors (1x1.5x1.5=2.25) resulting in 2 points for competitors that did not forfeit any games nor earn placement points.

# **ILSA Member Responsibilities**

If there has not been an ILSA announcement of a tournament that you are signing up for or have already competed in, the ILSA member should notify the ILSA executive board. Please use the method provided to report this event.

# **Board Responsibilities**

## **Designation of Point Earning Events**

The ILSA Executive Board awards state points at their discretion and may choose not to award points for a competition. This shall be communicated at or before registration for said competition.

The ILSA Executive Board may, at its discretion, vote to award Illinois State Points for placement and/or participation in any other tournament or league.

## Notification of Point Earning Opportunities

For all ILSA-hosted events, the ILSA Executive Board or a Commission they designate for an event shall publish an estimate of how many points will be awarded at or before registration for said competition based on the estimated number of competitors. For all other events, this estimate will be provided when possible. The final number of points to be awarded shall be announced prior to the start of the competition.

## **Tracking Points**

The ILSA Executive Board or a Commission they designate shall keep track of all points earned by its members, both per-season and lifetime. This information should be published in a way of their choosing, so it can be audited by any member for inaccuracies.

# Member Reporting

The ILSA Executive Board or a Commission they designate shall provide members a way to report tournaments and results where they have placed/participated. There should also be a way to report results/inaccuracies in the tracking points system.

The ILSA Executive Board and 2025 points commission understand this is a significant change from the Version 1.0 points system. Appendix 1 has comparisons and examples.


As you can see, there are now five ranges for the number of competitors/entries. This allows for expansion of the number of placement opportunities.

Version 2.0 also rewards consolation and participation points for all events; Version 1.0 awards these only for National events.

#### Factors:

As described in this document, Version 2.0 has three factors that influence base points.

#### **Factors**



This allows for a rating system to value:

- Singles over doubles/team AND
- IL events over events outside the state borders

A simple calculator sheet can take the base points and work out the math.

\*National points, in Version 1.0, followed the national points scale which awards one participation point to all and placement points for the top four in main and consolation.

- ILSA Challenge was an ILSA-hosted Top Tier Singles League and did not have a consolation bracket.
- Royal Palms Valentangs was a singles, ILSA Community Member-hosted tournament without a consolation bracket.
- ILSA Fundamentals was an Other ILSA-hosted Singles League without a consolation bracket.
- ILSA National was held at Royal Palms Chicago, IL, and was an any-doubles, ILSA-hosted National tournament.
- The Mad Hatter was a singles, other board approved tournament with a consolation bracket that didn't break the 3<sup>rd</sup>/4<sup>th</sup> placement ties.

- Mirror Lake was held at St Petersburg Shuffleboard Club, FL and in 2024 had a main bracket for the top 16 entries.
- The NYSA Nationals was held at Royal Palms Brooklyn, NY, and was an any-doubles, other National tournament.
- Lakeside, OH club hosted several tournaments. The Mens non-walking singles had about 30 entries, the Women's division had <16 entries. Therefore, both divisions receive points based on the range for <u>17-32</u> entries
